- 3. Tenders received without "Terms and Conditions of the Tender of Sale of Scrap" duly signed are liable to be rejected.
- 4. Incomplete Tender or Tenders submitted with qualifying conditions or with conditions at variance with the Terms and Conditions of tender of Sale of Scrap, are liable to be rejected summarily.
- 5. The tenderer shall have no right to issue addenda to the tender documents to clarify, amend, modify, supplement or delete any conditions or items stated therein.
- 6. Unless otherwise specified, all rates and prices in the tender form should be quoted both in figures and words. Tenders containing over-written or erased rate/rates are liable to be rejected.

17. Delivery Period:

The successful tenderer shall lift the full material / materials allotted to him by employing labour and transport at his own cost immediately after receiving the delivery order from MPS or within such time as may be prescribed in the delivery order. The successful tenderer shall lift the material / materials only from the quantity / site / space as may be earmarked / demarcated by NGEF (H) LTD., which is final and binding on them. The tenderer shall observe the rules and regulations and working hours as fixed by NGEF (H) LTD., The successful tenderer shall follow the procedures for taking the material / materials out of the factory premises as prevailing in NGEF(H) LTD., within the time allowed in this behalf without causing any damages to the property of NGEF(H)LTD., and at his own risk.

- 18. The quantities indicated in the tender notification are approximate. At the time of lifting the material the payment shall be made on actual basis.
- 19. Default in the payment by the successful tenderer :

In case of default in payment within the time limits specified in the Letter of Acceptance or intimation, the due payment be made together with additional charge at 1% per week or part thereof on the due amount to the period of delay within 14 (Fourteen) calendar days from the due date or as stipulated in the Acceptance Letter.

20. Default in lifting by the successful tenderer.
